<b>• Applicants shall not be granted more than one postponement or continuance per application.</b>

The Planning commission may reject additional information or table any issue due to new information that is submitted at the time of public hearing that may be of such an amount or technical nature that it cannot be reasonably read and understood, unless the new document/information is being submitted only to contradict evidence presented at the public hearing.
