REQUEST: To grant a waiver to the following section of the Kenton County Subdivision Regulations: (1) Article 3.5 -1 of the Kenton County Subdivision Regulations which requires that all newly created lots be located along an existing Public Street or Roadway accepted for maintenance by the applicable Legislative Body if the proposed lots will be used for building purposes. (2) Article 4.2-9 (E) of the Kenton County Subdivision Regulations. Granting this waiver would allow the Applicant to exceed the maximum number of contiguous flag lots along an existing streets. The Subdivision Regulations set this maximum value to 2.
