LOCATION: An area of approximately 27 acres located approximately 950 feet south of Hogrefe Road and approximately 120 feet east of Melbury Court, east of the existing terminus of Berlander Drive, in Unincorporated Kenton County.

REQUEST: A proposed map amendment changing the described area from A-1 (Agricultural-One) Zone to R-1E (Residential One-E) Zone. This issue was tabled at the July 10, 2024, meeting

SUMMARY: The applicant is proposing to subdivide the property into single-family lots with a minimum lot area of 7,500 square feet.
