
## Auditor's Report on Internal Control and Compliance

- ▶ Every audit involves a review of internal controls such as:
  - Segregation of the following financial duties:
    - Approval for transaction to take place
    - Control of cash
    - Recordkeeping
    - Reconciliation to bank, revenue records, disbursements
  - Control over financial reporting
    - GAAP accruals
    - Monthly closing adjustments
- ▶ Internal Controls – There were no *significant deficiencies* or *material weaknesses* in internal controls noted
- ▶ Compliance – There were no instances found of violations of laws or non-compliance with regulations, agreements or covenants

### For the Years Ended June 30th





For the Years Ended June 30th



Total Revenues – \$1,879,633 +5.8%



For the Year Ended June 30th, 2025


Total Expenditures – \$1,889,815 +8%
