The Boone County Planning Commission has drafted an update to the *Boone County Comprehensive Plan – Plan 2040* (adopted in 2019) as required by the Kentucky Revised Statutes, Chapter 100. The Planning Commission has revised the statements of Goals and Objectives, adopted in September of 2024, which have served as a guide for updating and completing the remaining Elements of the countywide comprehensive plan. The draft **Our Boone County – Plan 2045** consists of 7 Elements: Demographics, Environment & Natural Resources, Cultural Resources, Economy, Public Facilities & Services, Transportation, and Land Use (text and maps). It contains research data and analysis, as well as projects future land uses.

The Boone County Planning Commission is notifying you of an upcoming Public Hearing to be held on **Wednesday, January 21, 2026, at 7:00PM in the Boone County Fiscal Courtroom** of the Boone County Administration Building, 2950 Washington Street, Burlington, Kentucky in order to present the draft of the *Boone County Comprehensive Plan – Our Boone County Plan 2045*. At the Public Hearing, staff will give a presentation on the updated Elements, and the public will have the opportunity to comment before the full Planning Commission.

To the chairs of the

- Kenton County Planning Commission,
- Kenton County Joint Board of Adjustment, and
- Kenton County Joint Code Enforcement Board:

I want to provide an update on safety and security protocols for meetings that we are working on with the Kenton County Fiscal Court. Due to increased safety concerns at public meetings nationwide—and given your three boards' significant public involvement with sometimes emotional issues—we plan to have Steve Hensley, Director of Kenton County Homeland Security, attend one of your upcoming meetings to have a safety and security briefing with your board members. We can do this in executive session. We are fortunate to have the Office of Homeland Security working with us on these matters.

Additionally, we can request a proactive law enforcement presence at meetings if you believe it's necessary. For instance, we've already asked law enforcement to be present at all future Joint Code Enforcement Board meetings, and the county is accommodating this without hesitation.

We always aim to be overprepared for these issues and hope we never have to activate any safety and security protocols, but if we do, I want you and your board members to be aware of and informed about the procedures in place. After the initial briefing with Mr. Hensley, we should aim to do this annually as a refresher.

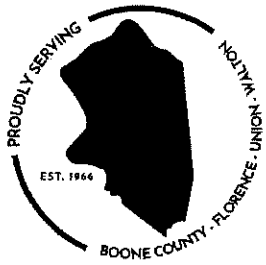
